# QUEEN CITY CHEVELLE CLUB 

Bylaws Adopted 1998 (revised 2/2007)

Article I<br>Purpose

Section 1: The purpose of the club shall be to promote the preservation and enjoyment of all 1964 through 1972 Chevelle and El Caminos.

Section 2: The club shall strive to develop family involvement in the hobby of automobile related activities.

Article II
Amendments
Section 1 : These bylaws shall remain unaltered except by a two-thirds (2/3) majority vote at any scheduled meeting.

Section 2 : Amendments to these bylaws may be added to by a two-thirds (2/3) majority vote at any scheduled meeting.

Article III
Membership
Section 1 : All members must pay to the treasurer such annual dues as required and approved by the majority of the members.

Section 2 : Dues shall be collected from each member upon the anniversary of their joining the club.

Section 3 : Dues shall be twenty dollars (\$20) per year.
Section 4 : The privilege of holding office, making motions and voting shall be limited to members whose dues are paid.

## Article IV <br> Meetings

Section 1: The club will hold its regular meetings at such time as recommended by its officers and approved by its members.

Section 2 : The location of regular meetings will be recommended by its officers and approved by its members.

Section 3 : The procedures of all meetings shall be informal, but held in an orderly manner.

Article V Officers

Section 1 : The officers of this club shall consist of a President, Vice-President, Secretary and Treasurer.

Section 2 : All elected officers must be U.S. citizens and twenty-one (21) years or older.

Article VI Board of Directors

Section 1 : The Board of Directors shall consist of three (3) club members.
Section 2 : All directors must be U.S. citizens and twenty-one (21) years or older.

Article VII
Term of Office
Section 1 : Each elected officer, director or appointed officer shall serve for one year or until his successor shall have been elected and qualified.

Article VIII
Elections
Section 1: Nominations and election of all officers and board members shall be in January of each year.

Section 2 : Nominations shall be made from the floor.
Section 3 : All elections shall be by ballot with the exception of an uncontested officer, and then a show of hands by the majority of the members is acceptable.

Section 4 : The new officers shall take office immediately following the election.

Article IX
Duties of Officers
Section 1: It shall be the duty of the President to preside at all meetings of the club, to enforce observance of the bylaws, decide all questions of order, call all special meetings and perform such other duties as the office may require and those required by these bylaws. He shall not vote on any motion or amendment, except elections or unless the club be equally divided, then he shall cast the deciding vote.

Section 2 : It shall be the duty of the Vice-President to assist the President and perform duties assigned to him. In the absence of the President, he shall perform the duties of that office.

Section 3 : It shall be the duty of the Secretary to keep full and complete minutes of all proceedings of the club. He shall keep a record of names and mailing addresses of all members and provide a monthly newsletter to each member.

Section 4 : It shall be the duty of the Treasurer to collect all dues and funds of the club. He shall make bank deposits and keep records of deposits. All bills are to be paid by check. His books shall be at all times open for examination and audit by the Board of Directors or at the request of any member.

## Article X

All Officers
Section 1 : All officers elected or appointed shall deliver to his successor all monies, books, records and other property of the club with proper accounting thereof.

Section 2 : All officers of the club shall perform the duties which are delegated or which may hereafter be delegated to them, respectfully, by the bylaws of the club or an amendment to the same.

## Article XI <br> Removal and Vacancy

Section 1: In case of the inability to serve as an officer, the remaining members shall appoint a member to serve the remainder of the term of that office.

Section 2 : An officer may be removed by two-thirds $(2 / 3)$ vote of the membership.

Article XII
Alcohol
Section 1 : Club funds shall not be used for the purchase of any alcoholic beverages.
Section 2 : Club meetings and fuctions shall be alcohol free.
